

**Acknowledgment of Risk:** The Undersigned acknowledges that mechanical bull riding is dangerous and that the participation in mechanical bull riding , as either a contestant, guest, employee, or volunteer, exposes the participant to a substantial and serious risk of property damage, personal injury and/or death . The Undersigned also acknowledges the risk of exposure to disease or infection while participating as either a contestant , guest, employee , volunteer or spectator in this activity .The Undersigned expressly acknowledges that his/her participation in mechanical bull riding will involve all such hazards.

**Release:** The Undersigned, being fully aware that participation in mechanical riding will expose him/her to a substantial and serious risk of property damage and/or personal injury and/or death, hereby releases Florida Party Works LLC , as well as their owners, officers, agents, employees, contractors, affiliates, management companies and anyone associated or connected in any way with Florida Party Works LLC from liability for any and all property damage, personal injuries, or other claims arising from the Undersigned's participation in mechanical bull riding , including those that are known, foreseen and unforeseen, future or contingent.
